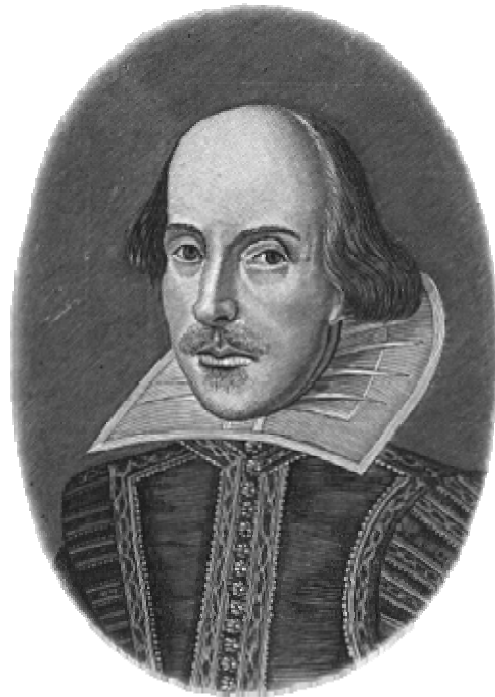

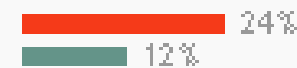
Which of the following comes closer to your opinion?
